### **Administrative History**

The first civic organization in Payson was the Payson Womans Club, founded in 1920. Their first goal was to bring in or designate an official clock in Payson for use by mail delivery and other businesses, as none of the clocks in the town at that time agreed with each other. Lena Chilson was elected as the first president of the Payson Womans Club in 1921. The Club's long-term goal was to bring a library to Payson; this was realized in 1987, when the town's first public library was established in the Payson Womans Club building on Main Street.

In 1939 Jay F. Vann willed his Arctic Extension mining claims to the Payson Womans Club. The majority of this collection pertains to the ownership of these claims. The remainder of the collection pertains to the history of the Payson Womans Club and its activities in Payson.

A note on spelling: Although other sources refer to the "Payson Woman's Club" or "Payson Women's Club," the club's own documentation usually lists the name as the Payson Womans Club; this naming style has been kept for this collection.

### **Scope and Content**

The collection consists of materials related to the history of the Payson Womans Club, its operation of the Payson Pioneer Cemetery and Payson Public Library, and its ownership of the Arctic Extension mining claims. Materials include bank books, correspondence, mining claims, receipts, promissory notes, permits, legal documents, manuscripts, photographs, and scrapbooks.

## **System of Arrangement**

Collection is arranged in the following series:

Series 1: Arctic Extension mining claims (Accession #1991.1.9)

Series 2: History of the Payson Womans Club (Accession #1995.20)

The original order for Series 1 has been lost; items were reordered in 2009 by staff members to correspond with the cataloging order as listed on accession documents (see processing notes). There is no apparent order for Series 2; this arrangement has been maintained.

# **Processing Information**

The materials regarding the Arctic Extension mining claims were originally filed with the Lena Chilson Hampton collection, accession # 1992.4. In 2009 staff members determined that the materials had been received and accessioned separately from the Lena Chilson Hampton collection; the materials were therefore removed from that collection and combined with accession # 1995.20 in this collection. During this move the materials were also reorganized based on the order they were listed in on the 1991 accession documents. The collection index was revised in February 2016 to match the current order.
