#### **Historical Note**

In 1891 August and Wilhelmina Pieper moved to Payson, Arizona. They bought out Henry Sidles, who had previously laid claim to the lots on either side of Main St., east of the Globe Road (McLane) going south from Main St. Sidles had built a mud house on the south side of Main and a saloon on the north side of Main. The Pieper's then laid squatter's claim to all of the land east from the Globe Road to beyond today's Highway 87, on both sides of Main Street, including the land along the American Gulch drainage. They also claimed the pasture land not previously claimed on the south side of Main west from the Globe Road. These properties were destined to be the heart of Payson for many years.

#### **Scope and Content Note**

The Harrison Collection contains articles about Main Street, chain of title documents, warranty deeds and a lease agreement on various properties on Main Street, Payson, Arizona. Also included are copies of the original documents.
