Subjects include historic roads, landmarks, business, vehicles, and buildings in the area, and areas relating to David Douglas Gowan. The collection also contains some textual material, including articles, biographies, and a copy of the Smugler Mine Claim.

Please note, while some of the photographs have dates and captions provided by Wolfe, many others have no information. The descriptions of many items in the collection index was provided by Stan Brown when he received the collection on behalf of the Northern Gila County Historical Society.
